FOSTER CARE AGREEMENT

Definitions

Kitten: the animal adopted under this agreement.

Vet: the relevant veterinary expert

Medication: any pills, tablets, food, liquids or otherwise prescribed for the animal by the veterinary expert

Shelter: Cat-a-holics Kitty Shelter

Fosterer: the individual fostering the animal

Foster home: the fosterer's residence

1. Medication and Vet Visits

1.1 Should the kitten(s) be on medication, I will continue the medication as directed/prescribed by the Vet.

1.2 Should the kitten(s) require medical attention, I will contact the Shelter immediately and inform them of the same.

1.3 The kitten(s) must only be taken to a Vet affiliated with the Shelter.

1.4 A reference number must be obtained from the Shelter before taking the kitten(s) to the Vet. The Shelter will only cover the costs associated with the consultation/medication provided that a reference number was obtained.

1.5 The kitten(s) must be taken to Merien at the Shelter prior to obtaining a reference number and taking the kitten(s) to a Vet.

2. The Adoption Process

2.1 The kitten(s) must not be given to any individual or otherwise unless authorised by the Shelter.

2.2 The kitten(s) remain the property of the Shelter and may not be sold, traded, disposed of or otherwise.

2.3 No impressions or consent may be given by the fosterer to any individual or otherwise regarding the kitten(s) being adopted by said individual without the express prior authorisation of the Shelter.

2.4 The fosterer must provide the Shelter with photos to advertise the kitten(s) for adoption from 6 weeks of age in order to ensure that the kitten(s) are adopted in a timely manner.

2.5 The fosterer must ensure that prospective owners are able to view the kitten(s) at the fosterer's residence.

2.6 The kitten(s) will be adopted from the foster home.

2.7 Any individual or otherwise that is interested in formally adopting the kitten(s), including the fosterer, must go through the adoption process. The Shelter has sole discretion with regard to who will take ownership of the kitten(s).

3. Foster care

3.1 The kitten(s) may not be outside fosterer residence on its own.

3.2 The kitten(s) may not be left in the care of any individual or otherwise not authorised by the Shelter.

3.3 Other animals owned by the fosterer must be up-to-date on all standard vaccinations and sterilised.

3.4 Any food or medication supplied by the Shelter is for the kitten(s) only.

3.5 If you elect to stop fostering the kitten(s) or have not fostered a kitten for over 6 months, all items that are the property of the Shelter must be returned to the Shelter unless otherwise agreed.

3.6 Fosterers must be prepared to keep the kitten(s) if the kitten(s) are unable to be adopted. Alternatively, to ensure there is space at the Shelter for the kitten(s) in the event that the kitten is not adopted, prior to accepting to foster a kitten(s).

3.7 Any items (milk, food, litter, blankets, medication etc.) required during the fostering process can be supplied by the Shelter. The fosterer must arrange with Kim or Merien for the ordering/purchasing of these products.

4. Indemnity

4.1 I understand that although the Shelter takes reasonable care to screen animals for foster care placement, it makes no guarantee regarding the health of the kitten(s), its behavior or actions.

4.2 Kitten(s) are received at the fosterer's own risk. It is up to the fosterer to reject and/or return any kitten(s) provided by the Shelter in a timely manner.

4.3 The Shelter is indemnified from all liability arising out of any and all claims, demands, losses, damages, action, judgment of any kind and description which may occur to or be suffered by the fosterer, members of the fosterer's household, the fosterer's own animals or any other party by reason of activities arising out of this agreement.

4.4 The fosterer indemnifies the Shelter from any and all responsibility, legal or otherwise, for any diseases that may be contracted by the fosterer's own animals resulting from the kitten(s).

All of the information I have provided on this application is, to the best of my knowledge, true and complete. I understand that any false or misleading information may disqualify me from fostering a kitten.
